The Charter Township of DeWitt resident has a bachelor's degree from Michigan State University, East Lansing, and an associate degree from Lansing Community College, Lansing.

As vice president of card services, Terri Carie is

responsible for managing LAFCU's credit and debit card portfolios, enhancing card programs and improving member experiences through technology and staff development.
